Item 1.01 Entry into a Material Definitive Agreement.

On September 20, 2004, Toys "R" Us, Inc. (the "Company") entered into letter agreements with Ms.

Francesca Brockett, formerly the Executive Vice President, Strategic Planning of the Company, pursuant to which the Company and Ms. Brockett agreed to certain terms and conditions relating to the remainder of her employment with the Company. Prior to Ms. Brockett's planned separation date of February 1, 2005, she will assume the title of Executive Vice President - Chief Strategy and Corporate Structure Officer and will continue to serve as a member of the Company's Executive Committee. In her new role, Ms Brockett will continue to lead the company's strategic review working closely with management and the Board of Directors. Pursuant to the agreements, Ms. Brockett's base salary and annual incentive target increased by approximately 10%, and payment of her target bonus for the fiscal year 2004 is guaranteed. Ms. Brockett will receive a special retention bonus of \$300,000 if she remains actively employed by the Company through February 1, 2005 or if her employment is terminated by the Company prior to that date for any reason other than for cause. If the parties mutually agree to extend Ms. Brockett's employment beyond February 1, 2005, she will receive additional monthly retention payments of \$60,000 per month for a maximum of three months.
