In 1997 Ms. Shogen pledged 150,000 shares to secure a loan. The lender claimed that such shares were transferred pursuant to the loan terms in February 2003; Ms. Shogen filed a Form 4 on October 13, 2005 to reflect the alleged transfer. Ms. Shogen subsequently filed a lawsuit against the lender to resolve this dispute. On July 25, 2006, Ms. Shogen and the lender settled the dispute and the lender agreed to transfer 75,000 of the pledged shares back to Ms. Shogen. This Form 4 reflects that transfer.
