As of the Date of Event, each of the Reporting Persons may be deemed to be the beneficial owner of 3,345,240 Shares. This number consists of (1) 2,667,658 Shares beneficially owned by the Reporting Persons and (2) 677,582 Shares issuable upon conversion of certain bonds beneficially owned by the Reporting Persons (the "Bonds").

ITEM 4(B) PERCENT OF CLASS:

As of the Date of Event, the number of Shares outstanding was 54,135,808 according to the Issuer's Quarterly Report on Form 10-Q for the quarter ended September 30, 2005 filed on November 4, 2005 (the "Quarterly Report"). As of the Date of Event, each of the Reporting Persons may be deemed to be the beneficial owner of approximately 6.10% of the total number of Shares outstanding. This percentage was calculated by dividing (i) (A) the total amount of Shares beneficially owned by the Reporting Persons, plus (B) the total amount of Shares issuable upon conversion of the Bonds, by (ii) (x) the total number of Shares outstanding as reported by the Issuer in the Quarterly Report, plus (y) the total amount of Shares issuable upon conversion of the Bonds.
