TENDER OFFER

The Tender Offer Statement on Schedule TO relating to the offer by MP ACQUISITION CO., LLC (the "Purchaser") to purchase up to 200,000 shares of the Common Stock, Par Value \$.01 (the "Shares") of ASSISTED LIVING CONCEPTS, INC., a Nevada corporation (the "Issuer") is hereby amended as set forth herein. Except as otherwise expressly amended hereby, the terms, conditions and disclosure set forth in the Schedule remain unchanged.

The Expiration Date has been extended to August 12, 2002, as of which date the Offer will terminate unless it is further extended. A total of 166 Shares have been tendered to Purchaser to date, and the Purchaser has been advised orally that an additional 460,850 Shares have been tendered by beneficial owners. The Purchaser is in the process of verifying with the transfer agent for the Issuer that these latter Shares are in fact the Shares and not the predecessor shares exchanged in the bankruptcy reorganization.
