In fact, as of March 14, 2007, Pabrai Investment Fund IV, LP owned only 899,021 shares, or 180 shares less than originally reported. As a result, the Forms 4 filed thereafter by the reporting person on November 15, 2007 and April 23, 2008 each overstated by 180 shares the amount of securities beneficially owned by Pabrai Investment Fund IV, LP.
