(1) Based on the Company's cash EPS growth in 2010, 107% of the original award of 4,432 performance-based restricted stock units granted 2/22/10 were earned, resulting in an additional 309 units, for a total of 4,741 units. The restrictions will lapse with respect to 1,580 units on 2/22/12 and with respect to 1,581 units on 2/22/13, subject to continued employment by the Reporting Person on the remaining vesting dates.

(2) Shares withheld by the Company to satisfy the Reporting Person's tax withholding obligation upon the vesting of restricted stock units.
