This amendment to the current report on Form 8-K filed by Global Partners LP on October 21, 2009 is being filed to restate the period for which the third quarter 2009 (July 1 – September 30) distribution was declared.

Item 7.01. Regulation FD Disclosure

On October 21, 2009, Global Partners LP (the Partnership) issued a press release announcing that the Board of Directors of its general partner, Global GP LLC, declared a quarterly cash distribution of \$0.4875 per unit (\$1.95 per unit on an annualized basis) on all of its outstanding common and subordinated units for the period from July 1, 2009 through September 30, 2009. On November 13, 2009, the Partnership will pay such cash distribution to its common and subordinated unitholders of record as of the close of business November 4, 2009.
