- Upon consummation of the transactions (the "Transactions") contemplated by the Transaction Agreement and Agreement and Plan of Merger, dated as of June 3, 2009, by and among Cowen Holdings, Inc. (f/k/a Cowen Group, Inc.), Cowen Group, Inc. (f/k/a LexingtonPark Parent Corp.), Lexington Merger Corp., Ramius LLC (f/k/a Park Exchange LLC) and RCG Holdings LLC (f/k/a Ramius LLC) ("RCG"), 37,536,826 shares of Class A Common Stock were issued to RCG. The Reporting Person is a member of RCG and may be deemed to have a pecuniary interest in 2,435,132 shares of Class A Common Stock that were acquired by RCG in the Transactions, including 2,376,924 shares that are held by RCG and allocated to the Reporting Person in connection with his ownership interest in RCG and 58,208 shares that are held by RCG and allocated to the Reporting Person's wife in connection with her ownership interest in RCG.
