On February 5, 2019, Argan, Inc. (Argan) issued a press release announcing that on January 31, 2019, its wholly owned subsidiary, Gemma Power Systems, entered into an engineering, procurement and construction services contract with and received a limited notice to proceed from Guernsey Power Station, LLC to construct a 1,875 MW state-of-the-art natural gas-fired power plant in Guernsey County, Ohio. Construction for the facility is scheduled to begin in the spring with completion scheduled in 2022.
