- (1) Represents Restricted Stock Units (RSUs) granted as the director's annual retainer equivalent to \$120,000 for the period beginning July 1, 2011 and ending June 30, 2012. Annual RSUs granted on and after July 1, 2011 vest in equal quarterly installments over a 12-month period beginning on the date of grant. Annual RSUs are payable solely in shares of Class A Common Stock. Director elected to defer the receipt of shares pursuant to the Towers Watson & Co. Compensation Plan for Non-Employee Directors filed with the SEC as Exhibit 10.1 to the Form 8-K filed by the Company on May 18, 2010. The deferred shares represent a value of \$120,000 based on the closing price of Company shares of \$65.71 on July 1, 2011, the date of the grant.
