They share voting and investment control over all securities owned by Special Situations Private Equity Fund, LP (PE) and Special Situations Fund III QP, L.P. (QP), respectively. 1,034,482 shares of Common Stock, 6,206,896 Wts A convertible into 310,345 shares of Common Stock and 2,068,965 Wts B, convertible into 103,448 shares of Common Stock, are held by PE and 317,037 shares of Common Stock, 634,076 Wts A convertible into 31,704 shares of Common Stock and 1,902,225 Wts B, convertible into 95,111 shares of Common Stock, are held by QP. Fund III, L.P. (SSF III), as filed by SSF III with the Securities and Exchange Commission on November 17, 2005, SSF III transferred the securities included in this Form 4 to QP on December 31, 2005.
