- (1) On May 23, 2013, the Company granted Mr. Houghton 66,254 shares of restricted stock of the Company (the "Restricted Stock") under the Company's 2004 Stock Incentive Plan. The Restricted Stock vests 6 months following the grant date.
- (2) On May 23, 2013, the Company granted Mr. Houghton an option to purchase 37,500 shares of common stock of the Company (the "Option") under the Company's 2004 Stock Incentive Plan. The Option vests in annual 25% installments on each of the first, second, third and fourth anniversaries of the grant date.
