On July 27, 2005, Integrated Device Technology, Inc. (the "Company") announced its results of operations and financial condition as of and for the quarter ended July 3, 2005 in a press release that is attached hereto as Exhibit 99.1.

The Company's press release contains non-GAAP financial measures. Pursuant to the requirements of Regulation G, the Company has provided reconciliations within the press release of the non-GAAP financial measures to the most directly comparable GAAP financial measures included in the press

release.

Non-GAAP Statements of Operations are presented in the press release. Non-GAAP Statements of Operations exclude acquisition-related charges and other expenses and benefits that management believes are not directly related to the Company's ongoing operations. For example, the results for the quarter ended July 3, 2005 exclude tax benefits related to the net reduction in tax reserves as a result of a partial settlement with the IRS, gains realized on the sale of assets held in connection with the earlier closure of the Salinas, California fabrication facility, an other-than-temporary impairment on our investment portfolio, and restructuring related expenses in connection with the actions taken over the last two quarters. The results for the quarter ended June 27, 2004 exclude an other-than-temporary impairment on our investment in NetLogic and restructuring related expenses in connection with reductions in force. These non-GAAP results are consistent with another way management internally evaluates results of operations and the Company believes this presentation format may be useful to readers of our financial results. However, the Company's non-GAAP results are not in accordance with GAAP and may not be comparable to non-GAAP information provided by other companies. Non-GAAP information provided in the Company's press release should be considered a supplement to, and not a substitute for, financial statements prepared in accordance with GAAP.

The foregoing description is qualified in its entirety by reference to the Company's Press Release dated July 27, 2005, a copy of which is attached hereto as Exhibit 99.1.
