Item 2.02 Results of Operations and Financial Condition

On February 5, 2015, Snap-on Incorporated (the “Corporation”) issued a press release entitled “Snap-on Announces Fourth Quarter and Full Year 2014 Results; *Diluted EPS of \$1.97 for the quarter increases 23.1%; Operating earnings before financial services of 16.9% of sales in the quarter improves 140 basis points; Organic sales up 9.8% in the quarter.*” The text of the press release is furnished herewith as Exhibit 99 and incorporated herein by reference.
