**Novo Nordisk A/S – Share repurchase programme**

**Bagsværd, Denmark, 31 January 2019** – On 5 November 2018, Novo Nordisk initiated a share repurchase programme in accordance with Article 5 of Regulation No. 596/2014 of the European Parliament and Council of 16 April 2014 (MAR), also referred to as the Safe Harbour rules. This programme is part of the overall share repurchase programme of up to DKK 15 billion to be executed during a 12-month period beginning 1 February 2018.

Under the programme initiated 5 November 2018, Novo Nordisk will repurchase B shares for an amount up to DKK 3.2 billion in the period from 6 November 2018 to 30 January 2019. The programme is now concluded.

Since the announcement as of 28 January 2019, the following transactions have been made under the programme:

With the transactions stated above, Novo Nordisk owns a total of 59,669,930 B shares of DKK 0.20, corresponding to 2.4% of the share capital, as treasury shares. The total amount of A and B shares in the company is 2,450,000,000 including treasury shares.

Novo Nordisk expects to repurchase B shares for an amount up to DKK 15 billion during a 12-month period beginning 1 February 2018. As of 30 January 2019, Novo Nordisk has since 1 February 2018 repurchased a total of 49,755,912 B shares at an average share price of DKK 301.47 per B share equal to a transaction value of DKK 14,999,986,372.
