- (2) These shares are owned by the Helen D. Blake 1993 trust, of which S. Prestley Blake's spouse, Helen D. Blake, is the trustee. S. Prestley Blake and Helen D. Blake disclaim beneficial ownership in these shares except to the extent of their pecuniary interest.
