Represents deferred stock units issued pursuant to his April 27, 2004 Chairman's Agreement with CONSOL Energy Inc. (the "Chairman's Agreement"). The deferred stock units are payable in shares of common stock on a one-for-one basis plus equivalent amounts credited to such stock units equal to the dividends declared on an equivalent number of shares of Company common stock.

(2) Of the 38,893 shares owned directly, 10,453 are deferred stock units including dividend equivalent rights.
