The number of DSUs acquired by the director was based on the weighted-average price at which the Company's restricted voting shares traded on the Toronto Stock Exchange on October 27, 2011 and October 28, 2011 (the two trading days prior to the acquisition date), which was \$1.38 (as converted from C\$1.37 using the average of the closing rates of exchange from Reuters on October 27 and October 28, 2011).
