- (1) Grant of restricted stock units. The restricted stock units vest in three equal installments: March 1, 2014; March 1, 2015; and March 1, 2016.
- (2) Includes the following purchases under the Chemtura Corporation Employee Stock Purchase Plan subsequent to the date of the reporting person's most recent filing on Form 4 providing Table I information: 192 shares on September 28, 2012; 136 shares on December 31, 2012.
- (3) Grant of stock options. The stock options vest in three equal installments: March 1, 2014; March 1, 2015; and March 1, 2016.
- (4) Grant of performance shares. Each performance share represents a contingent right to receive between 0 and 2 shares of Chemtura Corporation common stock. The actual number of shares to be delivered will be based on Chemtura Corporation's total shareholder return over the three-year vesting period relative to all companies in the Russell 3000 Index and could equal 200% of the target amount.
