(1) On March 27, 2009, Time Warner Inc. distributed its shares of the Issuer's common stock to its stockholders of record on March 12, 2009 with each such Time Warner Inc. stockholder receiving .083670 of a share of the Issuer's common stock for each share of Time Warner Inc. common stock held on the record date (the "Spin-off Dividend"). Amount represents an additional 4,154 shares of the Issuer's common stock not previously reported that were received by the Reporting Person as a result of the Spin-off Dividend in a transaction exempt pursuant to Section 16a-9 under the Securities Exchange Act of 1934. These shares were inadvertently omitted from the Reporting Person's Form 4 originally filed on April 16, 2009.
