- (3) Balance includes 216 shares acquired on 12-10-05 through the automatic dividend reinvestment feature of Exelon plans.
- (4) Shares withheld by the Issuer for reporting person's tax obligation.
- (5) Balance includes 122 shares acquired on 12-10-05 through the automatic dividend reinvestment feature of Exelon plans.
