THE FOLLOWING DISCLOSURE WAS INCLUDED IN ITEM 3.01 OF A CURRENT REPORT ON FORM 8-K FILED WITH THE SECURITIES AND EXCHANGE COMMISSION BY EMBARCADERO TECHNOLOGIES, INC., ON NOVEMBER 17, 2006:

On November 15, 2006, Embarcadero Technologies, Inc. (the <u>Company</u>) received a Staff Determination Letter from the NASDAQ Stock Market (<u>NASDAQ</u>), stating that the Company is not in compliance with NASDAQ Marketplace Rule 4310(c)(14) because it has not filed its Quarterly Report on Form 10-Q for the period ended September 30, 2006 in a timely manner. NASDAQ Marketplace Rule 4310(c)(14) requires the Company to file with NASDAQ, via EDGAR filing with the Securities and Exchange Commission (the <u>SE</u>C), on a timely basis all reports and other documents required to be filed with the SEC.

The Staff Determination Letter indicated that the Company s securities will be delisted from NASDAQ unless the Company requests a hearing before a NASDAQ Listing Qualifications Panel (the <u>Panel</u>). The Company intends to request a hearing before the Panel on or before November 22, 2006, as permitted by the letter, to review the staff s determination. A timely request for a hearing will stay the delisting pending the hearing and a decision by the Panel. Until the Panel issues a determination, the Company s common stock will continue to be traded on NASDAQ. There can be no assurance that the Panel will grant the Company s request for continued listing.

The Company issued a press release on November 17, 2006 disclosing, among other things, its receipt of the Staff Determination Letter.
