<b>Interest Payment Dates:</b>	Interest will be paid semiannually on February 18 and August 18, beginning on February 18, 2009 to holders of record as of the preceding February 5 and August 5, respectively.
<b>Day Count:</b>	30/360
<b>Use of Proceeds:</b>	The net cash proceeds from the sale will be used for general corporate purposes. Pending such use, we may temporarily invest net proceeds in interest-bearing, investment-grade securities.
<b>Series:</b>	The Notes are part of a series of debt securities entitled Medium-Term Notes, Series A that we may issue under the Indenture. We may re-open this series of Notes, and issue additional Notes of this series under the Indenture in the future.
<b>Exchange Listing:</b>	The Notes will not be listed on any national securities exchange.
<b>Denomination:</b>	We will issue the Notes in denominations of \$1,000 and in integral multiples thereof.
<b>Book-Entry System:</b>	The Notes will be issued only in fully registered form without interest coupons. Beneficial interests in the Notes will be shown on, and transfers of those beneficial interest can only be made through, records maintained by the Depository Trust Company and its participants.
<b>Ratings:</b>	A3 (Moody's); BBB+ (Standard & Poor's); A (low) (DBRS); and A- (Fitch).

On August 11, 2008, Moody's placed the ratings of Zions Bancorporation under review for a possible downgrade.
