As previously announced, on August 23, 2012, Fifth Third Bancorp ( Fifth Third ) entered into an accelerated share repurchase transaction with Goldman, Sachs & Co. ( Goldman ) pursuant to which Fifth Third would purchase approximately \$350 million of its outstanding common stock. Fifth Third is repurchasing the shares of its common stock as part of its previously announced 100 million share repurchase program, which had approximately 100 million shares remaining.

On October 22, 2012, Fifth Third was notified by Goldman that effective Friday, October 19, 2012, they had finished purchasing shares under the August 23rd agreement. A total of 21,531,100 shares were repurchased upon execution of the agreement, and an additional 1,444,047 were repurchased upon completion of the agreement. The additional shares are expected to settle on October 24, 2012. In total, 22,975,147 shares are being repurchased at an average price of \$15.2339.

Upon completion of the accelerated share repurchase transaction, Fifth Third will have remaining authority to repurchase approximately 77 million shares under its previously announced share repurchase program.

Goldman and certain of its affiliates have performed, and in the future may perform, various financial advisory and other services for Fifth Third and Fifth Third's affiliates for which they have received, and may in the future receive, customary fees and expenses.
