**Item 2.02. Results of Operations and Financial Condition**

On July 27, 2016, Entercom Communications Corp. (the **Company** ) issued a press release (the **Press Release** ) announcing second quarter and year to date 2016 results. Specifically, for the second quarter of 2016 the Company announced:

net revenues of \$120.5 million;

station operating expenses of \$82.6 million;

corporate general and administrative expenses of \$8.5 million;

operating income of \$27.6 million;

net income available to common shareholders of \$10.4 million; and

net income available to common shareholders per share diluted of \$0.26.

For the six month period ended June 30, 2016, the Company announced:

net revenues of \$216.6 million;

station operating expenses of \$154.4 million;

corporate general and administrative expenses of \$16.1 million;

operating income of \$42.3 million;

net income available to common shareholders of \$14.4 million; and

net income available to common shareholders per share diluted of \$0.37.
