- (1) This grant was made pursuant to the issuer's non-employee director compensation policy. The shares underlying this restricted stock award will vest in full on the earlier of (i) August 20, 2011 or (ii) the date immediately preceding the date of the issuer's 2011 annual meeting of stockholders.
