- (1) As provided in the Issuer's Amended and Restated Certificate of Incorporation, each share of Class B Common Stock is convertible at any time, at the option of the holder, into one share of Class A Common Stock. In addition, each share of Class B Common Stock will convert automatically into one share of Class A Common Stock upon any transfer, whether or not for value, except for certain permitted transfers described in the Issuer's Amended and Restated Certificate of Incorporation.
- (2) On January 3, 2012, the trustee of the Reporting Person distributed 57,065 shares of Class B Common Stock beneficially owned by the Reporting Person, which were contributed to a trust for the benefit of a spouse of a lineal descendant of Nicholas J. Pritzker, deceased. No consideration was paid in connection with the distribution of shares from the Reporting Person or the receipt of shares by the recipient trust. The transfer of shares of Class B Common Stock to the recipient trust constitutes a "permitted transfer" as defined under the Issuer's Amended and Restated Certificate of Incorporation. Contemporaneous with such receipt of shares, the trustee of the recipient trust has executed joinders to, and thereby has become subject to the provisions of, the Amended and Restated Global Hyatt Agreement and the Amended and Restated Agreement Relating to Stock. Accordingly, immediately following the receipt of shares, the shares remain shares of Class B Common Stock.

Remarks:

Member of 10% owner group. John Kevin Poorman serves as trustee of the Reporting Person and has investment power over shares owned by the Reporting Person. The beneficiary does not have investment power over the shares of Class B Common Stock owned by the Reporting Person. In addition, the Reporting Person may be deemed to be a member of a group because the Reporting Person has agreed to certain voting agreements and limitations on transfers of shares of Class A Common Stock and Class B Common Stock. Reporting Person disclaims beneficial ownership of the securities reported herein except to the extent of its pecuniary interest in the securities.
