 Between January 29, 2011 and January 28, 2012, the reporting person acquired 2,158,7827 shares of Kroger common stock in the Company's employee benefit plans that are deemed to be 'tax-conditioned plans' pursuant to Rule 16b-3, to the extent disclosed on reports received by plan trustees.
