(1) As of the effective time (the "Effective Time") of the transactions contemplated by the Amended and Restated Agreement and Plan of Merger by and among IntercontinentalExchange, Inc., IntercontinentalExchange Group, Inc. ("ICE Group"), NYSE Euronext, Braves Merger Sub, Inc., and NYSE Euronext Holdings LLC (formerly known as Baseball Merger Sub, LLC) (the "Merger Agreement"), each restricted stock unit of NYSE Euronext held by the reporting person was converted into an award of a substantially equivalent restricted stock unit denominated in ICE Group Common Stock, as adjusted by the equity exchange factor of 0.2275, pursuant to the terms of the Merger Agreement. (This footnote is continued onto footnote 2).

(2) The common stock referred to in Table I represents restricted stock units of ICE Group held by the reporting person immediately following the Effective Time. Each restricted stock unit represents the right to receive one share of common stock of ICE Group upon the reporting person's termination of service on the Board of Directors for any reason other than termination for cause.
