Derivative securities beneficially owned include (i) 6,850,188 OP Units of which Reporting Person disclaims beneficial ownership, except to the extent of his pecuniary interest therein, 697,288 OP Units held by Rivermouth and 810,125 OP Units held by trusts f/b/o Reporting Person's spouse and children, (ii) 7,397 LTIP Units, and (iii) 274,355 stock options.
