On January 19, 2012, an amended version of the Code was filed with the SEC on Form 6-K and made available on the Registrant's website.

The key amendments made to the Code at that time, included the addition of new wording at: a) Section 2C – Gifts and Entertainment and Section 2G – Bribery, to add more clarity around the Anti-Bribery and Anti-Corruption policies and related policies and procedures; b) Section 2G – Short Selling or Trading in Options of TD Bank Securities, to highlight the prohibition against hedging market risk for equity compensation awards; c) Section 7B – Reporting Violations, to clarify a) that employees are also required to report violations of related policies, supplemental codes, compliance manuals, etc., in addition to reporting violations of the Code; and b) to streamline and simplify the external reporting process mandated by the Whistleblower Policy to make it easier to report Code violations confidentially and anonymously. In addition to these changes, certain other editorial, technical, administrative and non-substantive amendments were made to the Code, including a decision-making process to help reinforce the message that decisions which engage ethical judgment should be approached cautiously.

No waivers from the provisions of the Code were granted in the fiscal year ended October 31, 2012 to the Registrant's Group President and Chief Executive Officer, Group Head Finance and Chief Financial Officer, and Senior Vice President and Chief Accountant.
