The final 5% increment will vest on the fifth anniversary of the grant date. The portion of this stock option grant exercised by the reporting person on February 22, 2005 vested as follows: 188 shares on March 31, 2004, 187 shares on June 30, 2004, 188 shares on September 30, 2004 and 187 shares on December 31, 2004.
