GOL Announces Traffic Statistics for August 2006

São Paulo, September 4, 2006 GOL Linhas Aéreas Inteligentes (NYSE: GOL and Bovespa: GOLL4), Brazil's low fare, low cost airline, today released preliminary passenger statistics for the month of August 2006. System-wide passenger traffic (RPK) increased 72%, while capacity (ASK) increased 47% y-o-y. GOL's system load factor for the month of August 2006 was 77%.

Domestic passenger traffic (RPK) for August increased 63%, and capacity (ASK) increased 39%. GOL's domestic load factor for the month of August 2006 was 77%. International passenger traffic (RPK) for August increased 297%, while capacity (ASK) increased 234%. International load factor for the month of August 2006 was 77%. Yield per passenger kilometer decreased 9% vs. August 2005, while average stage length (passenger trip) increased 11%.
