### **Euroseas Ltd. to Sell Handysize Bulk Carrier**

**Maroussi, Athens, Greece March 21, 2006** Euroseas Ltd., (OTCBB: ESEAF, CVAP) an owner and operator of drybulk and container carrier vessels and provider of seaborne transportation for dry bulk and containerized cargoes, announced today that it has signed a Memorandum of Agreement to sell M/V John P a handysize bulk carrier of 26,354 dwt built in 1981 for \$4.95 million. The vessel is to be delivered to the buyers in late June / early July 2006.

Following the sale of M/V John P the Company will have a fleet of 7 vessels, including 1 Panamax drybulk carrier, 3 Handysize drybulk carriers and 3 Handysize containerships. Euroseas four drybulk carrier vessels have a total cargo capacity of 164,550 deadweight tons (dwt) and its containerships have a cargo capacity of 66,100 dwt and 4,636 twenty-foot equivalent units (teu).

Aristides Pittas, Chairman and CEO of Euroseas commented: Our overall strategy is to maximize our shareholders return by taking advantage of the shipping cycles and grow our company at the right time by focusing on age and size segments that maximize return on equity. In this context, we entered in an agreement to sell our M/V John P for a gross price of 4.95m USD. With these proceeds, the cash available from the private placement we completed in August 2005 and by utilizing standard leverage, we are currently in a strong position to take advantage of market opportunities, as they may occur in 2006.

#### **About Euroseas Ltd.**

Euroseas Ltd. was formed on May 5, 2005 under the laws of the Republic of the Marshall Islands to consolidate the ship owning interests of the Pittas family of Athens, Greece, which has been in the shipping business over the past 125 years. Currently, Euroseas Ltd. owns and operates 8 vessels, including 4 Handysize dry bulk carriers, 3 Handysize containerships, and 1 Panamax drybulk carrier. Euroseas operates in the drybulk and container shipping markets, with operations managed by Eurobulk Ltd., an ISO 9001:2000 certified affiliated ship management company, which is responsible for the day-to-day commercial and technical management and operations of the vessels. Euroseas' five drybulk carrier vessels have total cargo capacity of 190,904 deadweight tons (dwt) and its containerships have cargo capacity of 66,100 dwt and 4,636 twenty-foot equivalent units (teu).
