The Rights are not currently exercisable or separately tradable and presently are evidenced by certificates for shares of the common stock. Value attributable to such Rights, if any, is reflected in the market price of the common stock.

- (2) Vesting on 05/06/2010 of restricted stock units under employer plan - data provided by plan administrator on 05/10/2010 Vesting occurs 25% per year over four years.
- (3) Shares withheld to cover required tax withholding on vesting of restricted stock effective as of 05/06/2010 - data provided by plan administrator on 05/10/2010.
- (4) With tandem tax withholding right
- (5) One share of Apache common stock for each restricted stock unit.
- (6) Restricted units granted 05/05/2010 under employer plan - data received from plan administrator on 05/07/2010. The units vest 25% per year on 06/01/2011, 05/05/2012, 05/05/2013 and 05/05/2014.
- (7) Stock option granted 05/05/2010 under employer plan - data received from the plan administrator on 05/07/2010. Exercisable ratably over four years beginning 05/05/2011.
