On March 29, 2004, Hemacare Corporation, a California corporation (the “Registrant”), filed with the Securities and Exchange Commission a registration statement on Form S-8 (File No. 333-114013) (the “Registration Statement”) registering an additional 1,250,000 shares of the Registrant’s common stock for issuance under the Registrant’s 1996 Stock Incentive Plan (the “Common Stock”).
