## Estimated Unaudited Assets Under Management

The Company is disclosing to investors in the private investment funds that it manages that, as of May 1, 2016, the estimated unaudited amount of assets under management was approximately \$13.6 billion, which reflects a net decrease of approximately \$0.09 billion since April 1, 2016. The Company's estimate of assets under management is inclusive of performance for the month ended April 29, 2016 and capital flows as of May 1, 2016.

The Company owns between 20% and 55% of the general partners, investment managers or managing members of (a) the real estate business, the activist business and the global macro business (the single strategy hedge funds) and the alternative solutions business. We do not possess unilateral control over any of these business.

(b) Includes approximately \$651 million of committed but undrawn capital that will only be charged fees when invested.

These amounts include the Company's invested capital of approximately \$153.3 million and \$163.5 million as of (c) May 1, 2016, and April 1, 2016, respectively (including investments in a registered investment company pursuing a hedge fund-style strategy).
