(CAYMAN) and Special Situations Private Equity Fund, L.P. (PE and together with QP and CAYMAN, the Funds). As the investment adviser to the Funds, AWM holds sole voting and investment power over 1,336,777 shares of Common Stock of the Issuer (the Shares) held by QP, 439,534 Shares held by CAYMAN and 296,857 Shares held by PE. Austin W.
