- (1) Received in exchange for 105,095 ordinary shares of Orbotech Ltd. in connection with the merger (the "Merger") of Tiburon Merger Sub Technologies Ltd. with and into Orbotech Ltd. Pursuant to the agreement governing the merger, each Orbotech ordinary share is entitled to receive \$38.86 and 0.25 of a share of KLA-Tencor Corporation common stock, with cash in lieu of a fractional share.
- (2) Received in exchange for 1,666 vested options to purchase Orbotech Ltd. ordinary shares at an exercise price of \$15.57 per ordinary share in connection with the Merger.
- (3) Received in exchange for 5,197 vested options to purchase Orbotech Ltd. ordinary shares at an exercise price of \$27.45 per ordinary share in connection with the Merger.
- (4) Each restricted stock unit ("RSU") represents a contingent right to receive one share of KLA-Tencor common stock.
