- Pursuant to terms of the Nonemployee Directors' Deferred Compensation Plan approved by the board of directors on February 11, 2000 and amended and restated on April 7, 2006, Mr. VerHage elected to receive his 2011-2013 stock award, meeting fees and retainer in Franklin Electric Co., Inc. common stock, issuance of such shares deferred until he retires or otherwise leaves the board of directors (e.g. (1) Stock Units). On May 2, 2013, Mr. VerHage was credited with 47.92 Stock Units for meeting attendance, 2715.65 units for the 2013 Stock Award, and 1597.44 for payment of the annual stock award, in addition to 3803.54 units received on March 18, 2013 when the stock split. At distribution, Mr. VerHage may elect pursuant to the terms of the Plan to receive his deferred compensation either in shares of Franklin common stock or in cash.
