On December 27, 2011, the reporting person exercised 50,000 stock options, delivered 7,864 shares of common stock of the Company for cancellation in partial payment of the exercise price of such options and had 13,006 shares of common stock of the Company withheld (1) and cancelled to cover minimum required tax withholding. These share cancellations are shown on Table I as dispositions (Transaction Code "D" in Column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in Column 3.
