On December 30, 2011, the reporting person in the aggregate exercised 1,333 stock options, delivered 582 shares of Common Stock of the Company for cancellation in payment of the exercise price of such options, and had 302 shares of Common Stock of the Company (1) withheld and cancelled to cover minimum required tax withholding. These shares cancellations are shown on Table I as dispositions (Transaction Code "D" in column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in column 3.
