- On February 25, 2008 Richard A. Bachmann settled his obligation to deliver shares of common stock of Energy Partners, Ltd. (The "Company") under a prepaid variable forward sales contract (the "Contract") entered into with an unaffiliated counterparty on February 25, 2005. To secure his obligation under the Contract, Mr. Bachmann pledged 200,000 shares to the counterparty. According to the
- (1) Contract, the number of shares to be delivered by Mr. Bachmann at settlement would be determined by a formula based on the closing price of the Company's common stock on the maturity date. The closing price of the Company's common stock on the maturity date was \$12.25 per share. Based on the formula, Mr. Bachmann delivered all 200,000 shares of the Company's common stock pledged under the Contract.
 - (2) Consists of 200,000 shares of the Company's common stock that Mr. Bachmann agreed to deliver as described in Footnote 1.
