The Reporting Persons may be deemed to beneficially own indirectly, in the aggregate, 74,868,148 shares of Cobalt International Energy, Inc. (the "Company") common stock, par value \$0.01 per share ("Common Stock"), through certain limited partnerships (the "Limited Partnerships"). Affiliates of GS Group and Goldman Sachs are the general partner, managing limited partner or managing partner of the Limited Partnerships. The Reporting Persons disclaim beneficial ownership of the securities reported herein except to the extent of their pecuniary interest therein.
- (2) The Common Stock of the Company reported herein as indirectly purchased were beneficially owned directly by Goldman Sachs and may be deemed to have been beneficially owned indirectly by GS Group. Without admitting any legal obligation, Goldman Sachs or another wholly-owned subsidiary of GS Group will remit appropriate profits, if any, to the Company.
