- (1) On February 28, 2017, Mr. Blacksberg was awarded these restricted limited partnership units ("LTIP Units") in Acadia Realty Limited Partnership (the "Company"). 14,149 LTIP Units shall vest as follows: equal amounts shall vest on January 6, 2018 and on each of the first, second, third and fourth anniversaries thereof, provided that Mr. Blacksberg continues to be employed on the vesting date in question. 50% of the remaining 7,545 LTIP Units will vest subject to the same schedule and Mr. Blacksberg's continued employment and the other 50% as follows: 60% shall vest on January 6, 2020, subject to Mr. Blacksberg's continued employment and the Company achieving certain cumulative benchmarks established by the Company's Board of Trustees. Provided that the initial 60% vests as described above and further provided that Mr. Blacksberg is continuously employed by the Company, 20% shall vest on January 6, 2021 and 20% shall vest on January 6, 2022.
- (2) This number represents the total number of LTIP Units (5,592 vested and 40,306 unvested) now held by Mr. Blacksberg.
