- (1) Cerberus ABP Investor LLC ("Cerberus ABP") is the holder of 270,398 shares of common stock, par value \$0.01 per share (the "Common Stock"), of BlueLinx Holdings Inc. (the "Company"). Stephen Feinberg, through one or more intermediate entities, possesses the sole power to vote and the sole power to direct the disposition of all securities of the Company held by Cerberus ABP. Mr. Feinberg's interest in such securities is limited to the extent of his pecuniary interest in Cerberus ABP, if any.
- (2) On October 23, 2017, Cerberus ABP sold to BTIG, LLC an aggregate of 4,443,428 shares of Common Stock at a sale price of \$6.58 per share, representing the \$7.00 public offering price per share less the underwriting discount of \$0.42 per share, pursuant to the terms of an underwriting agreement dated October 18, 2017. The terms of the related public offering are described in a prospectus supplement filed by the Company with the Securities and Exchange Commission on October 19, 2017.
