1. Announcement re organizational changes dated November 28, 2005.

Petach Tikva, Israel, November 28, 2005

After completing an assessment of future changes in the Israeli communication market, the company today announced organizational changes in its management structure.

One of these changes will be the merger of the company's residential and business divisions. The new consolidated division will be responsible for all service and sales to the company's residential and business customers and will be managed by a senior and experienced officer. The company is also appointing a new Vice President of Marketing.

Mr. Arik Alster, IGLD's Deputy Chief Executive Officer submitted his resignation, effective as of November 24, 2005. In the last nine years Mr. Alster held various management positions in the Company and was appointed as the Company's Deputy Chief Executive Officer one year ago.

Internet Gold is a communications company that provides Internet access and related value-added services, international telephony, e-advertising, content and e-Commerce services throughout Israel under the brand name "smile" to both residential and business customers.

Internet Gold's operations are carried out through four subsidiaries. Through MSN Israel, its (50.1% owned) joint-venture with Microsoft Corp. (49.9% owned), the Company operates several of Israel's Internet portals. Its fully-owned subsidiary, Internet Gold International, specializes in the provision of international Internet and communication services. Its fully-owned subsidiary, GoldMind, focuses on the provision of Internet value-added services. Through GoldTrade, its fully-owned e-Commerce subsidiary, the Company has established itself as one of Israel's leading e-Commerce providers.
