As of the close of business on December 31, 2016 (i) BVF beneficially owned 610,980 shares of Common Stock, (ii) BVF2 beneficially owned 393,680 shares of Common Stock, and (iii) Trading Fund OS beneficially owned 117,999 shares of Common Stock.

Partners OS as the general partner of Trading Fund OS may be deemed to beneficially own the 117,999 shares of Common Stock beneficially owned by Trading Fund OS.

Partners, as the general partner of BVF, BVF2, the investment manager of Trading Fund OS, and the sole member of Partners OS, may be deemed to beneficially own the 1,320,164 shares of Common Stock beneficially owned in the aggregate by BVF, BVF2, Trading Fund OS, and certain Partners Managed accounts (the “Partners Managed Accounts”), including 197,505 shares of Common Stock held in the Partners Managed Accounts.

Mr. Lampert, as a director and officer of BVF Inc., may be deemed to beneficially own the 1,320,164 shares of Common Stock beneficially owned by BVF Inc.

Partners OS disclaims beneficial ownership of the shares of Common Stock beneficially owned by Trading Fund OS. Each of Partners, BVF Inc. and Mr. Lampert disclaims beneficial ownership of the shares of Common Stock beneficially owned by BVF, BVF2, Trading Fund OS, and the Partners Managed Accounts, and the filing of this statement shall not be construed as an admission that any such person or entity is the beneficial owner of any such securities.

(b) Percent of class:

The following percentages are based on 25,409,177 shares of Common Stock outstanding as disclosed in the Issuer’s Quarterly Report on Form 10-Q filed with the Securities and Exchange Commission on November 9, 2016.

As of the close of business on December 31, 2016 (i) BVF beneficially owned approximately 2.4% of the outstanding shares of Common Stock, (ii) BVF2 beneficially owned approximately 1.6% of the outstanding shares of Common Stock, (iii) Trading Fund OS beneficially owned less than 1% of the outstanding shares of Common Stock (iv) Partners OS may be deemed to beneficially own less than 1% of the outstanding shares of Common Stock, and (v) each of Partners, BVF Inc. and Mr. Lampert may be deemed to beneficially own approximately 5.2% of the outstanding shares of Common Stock (less than 1% of which is held in the Partners Managed Accounts).
