The Bank of New York Mellon Corporation, One Wall Street, New York, NY 10286, U.S.A., disclosed on February 3, 2015, that its total holding in Syngenta now amounts to 3,185,561 shares (3.43% of the total share capital), split into 3,173,102 registered shares plus purchase rights on ADRs (ISIN US87160A1007, 1 ADR=0.2 share) corresponding to 12,459 shares.
