The subject quarterly report on Form 10-Q for the fiscal quarter ended March 28, 2004 could not be filed without unreasonable effort or expense because, as announced by the Registrant on May 13, 2004, the Registrant and all of its domestic subsidiaries filed voluntary petitions for relief under Chapter 11 of the United States Bankruptcy Code in the Bankruptcy Court for the Southern District of Ohio-Dayton Office (Case No. 04-34091) on May 12, 2004. During the period immediately prior to the filing of the Chapter 11 petition, the Registrant's management team devoted virtually all of its time and effort negotiating a potential sale of substantially all of the Registrant's domestic subsidiary assets and preparing the necessary information for the Registrant's bankruptcy filing. All of the management personnel necessary for collecting and preparing the necessary information for the bankruptcy filing are also responsible for preparing the Registrant's Form 10-Q. Based upon the foregoing and the close proximity in time between the bankruptcy filing and the Form 10-Q filing, the Registrant is unable to complete its Form 10-Q for the quarter ended March 28, 2004 within the prescribed time period without unreasonable expense or effort.

In light of its bankruptcy filing, the Registrant also intends to seek no-action relief from the Staff of the Securities and Exchange Commission from its reporting obligations under the Securities Exchange Act of 1934, as amended (the "Exchange Act"). If such relief is granted, the Registrant will follow the modified reporting procedures set forth in its no-action request in lieu of filing the subject quarterly report within the time period prescribed by Rule 12b-25 under the Exchange Act.
